

Licensing and responsible business practices for gold mining in Sagaing Region Multi-stakeholder Workshop 9-10 March 2019

CONCEPT NOTE AND DRAFT AGENDA

The Government of Myanmar's 2018 Myanmar Sustainable Development Plan identifies as an action point 5.5.3: 'Reform the nature of the minerals sector such that it becomes both sustainable and profitable, while making both a positive contribution to government revenues and to the lives of our people'.

The mining sector in Myanmar – large, small and artisanal - is currently associated with significant negative environmental and social impacts. These were documented in Myanmar Centre for Responsible Business' March 2018 Sector-Wide Impact Assessment on Limestone, Gold and Tin Mining in Myanmar which inter alia included field research on gold mining conducted in Banmauk, Kawlin and Homalin, Sagaing region as well as in Kachin State, Bago region and Mandalay region, and made recommendations to government, companies and other stakeholders on improving responsible mining practices.

Sagaing Region is highly prospective for large, medium, small-scale and artisanal gold mining. As a result of Myanmar's new Mines Rules of February 2018, State/Region committees, rather than the Union-level Ministry of Natural Resources and Environmental Conservation (MONREC), will issue most artisanal and small-scale mining (ASM) licenses, including for gold, silver, lead, tin, tungsten, and most industrial minerals and stones. The Union government will only maintain responsibility for specific restricted minerals (including copper, nickel, titanium, uranium, zinc and rare earths inter alia), and stones (graphite and zinc carbonate).

The Mines Rules define artisanal and small-scale licenses by size as:

Artisanal:

Gold & other precious metals <1 acre; Other metals <3 acres; Industrial minerals & stone <5 acres **Small-scale**:

Gold & other precious metals < 4 acres; Other metals <10 acres; Industrial minerals & stone <20 acres

License fees, land rent and royalties from the sector will also be levied and collected at the states/region level.

The Committees will be chaired by the State/Region Minister of Natural Resources and Environmental Conservation and include senior officials from the State/Region General Administration Department, Department of Agricultural Land Management and Statistics (DALMS), Forestry Department, Environmental Conservation Dept, as a well as an additional official selected by the state/region cabinet. The State/Region Department of Mines will be Committee Secretary.

However, these Rules were issued without first establishing clarity over how to address overlapping claims from licences issues at Union level for large and medium-scale mining, and those issued at state/region level. There is also no mining cadastre yet in place that could help avoid overlap.

Furthermore, the ASM sector in Myanmar is associated with significant environmental and social impacts (see MCRB's SWIA) which are not effectively addressed through the 2018 Mining Rules, although these support its formalisation. Nor are clear procedures in place to ensure transparent processes for allocation of licences at state/region level. This lack of legal clarity is already leading to problems in some states and regions, particularly Sagaing, where large-scale licences for prospecting/exploration have been issued on area which are the subject of interest for ASM miners. ASM zones have been proposed as a solution, but their potential address these problems is unclear.

The Sagaing Regional Government/Parliament is interested in legislating on mining. But in seeking effective solutions to these issues, including through regulation, it is important to ensure that all stakeholder perspectives are heard and understood by those involved in the debate. MCRB therefore proposes to conduct a multi-stakeholder workshop in Monywa focused on licensing and management of responsible gold mining in Sagaing Region. The workshop is planned for 9/10 March 2019] with the following **objectives**:

- Provide all stakeholders with a basic understanding of:
 - o Myanmar policy/legal framework for mining, including decentralization of licensing
 - The nature of large-scale, small-scale and artisanal mining including the mining project cycle (prospecting, exploration, construction, production, closure)
 - Responsible mining practices
 - o Zoning of ASM, based on international experience

Discuss

- Negative social and environmental impacts of the mining sector in Sagaing Region and how to address these, including drawing on international experience
- Current licencing issues related to large-scale gold mining (LSM) and ASM, and how to resolve them, including the potential for ASM to co-exist and regulatory and other changes needed to facilitate this
- Identify actions/next steps at Union and Sagaing Region level

The workshop will be conducted with simultaneous interpretation. Target participants (50-60) will be Sagaing Region Government, Union and Sagaing region officials (MONREC – Mining, Forestry and Environmental Conservation Department; DALMS; DICA; GAD), Members of Parliament, Companies (ASM and LSM), Civil Society, international NGOs and development partners.
