PeaceNexus and MCRB convene 'design workshop' on company-community dialogue and mediation

Private Sector involvement in Disaster Relief

The Union of the Myanmar Federation of Chambers of Commerce and Industry (UMFCCI) and some foreign and Myanmar companies are initiating collaboration with United Nations agencies (OCHA and UNDP) to enhance coordination between UN, NGOs, government and the private sector) when responding to disasters (floods, earthquakes etc). A core working group has been formed to define initial Terms of Reference which might lead to the establishment of a private sector network similar to other countries e.g. Philippines.
