### **Responsible business** seminar series

MCRB has launched a series of seminars on responsible business. These will be held in cooperation with the International Labour Organisation, interested companies and business associations and with the involvement of Myanmar Investment Commission (MIC) and the Directorate of Investment and Companies Administration (DICA). They are intended to help all types of businesses to operate responsibly, consistent with Myanmar's Investment Law and Policy, and will cover issues such as business integrity, decent work, environment and community engagement. The concept was <u>discussed with MIC on 22 June</u>, together with a group of companies committed to contributing their experience. A <u>kick-off workshop was held</u> <u>together with the OECD</u> on 5 July, at which Heineken and Shwetaung spoke on 'due diligence'. ## Sand Extraction in Myanmar

At the intersection of two MCRB's SectorWide Impact Assessments on <u>Tourism</u> and <u>Mining</u> sits sand extraction. Unregulated extraction poses a growing threat to Myanmar's ecosystems which inter alia support economies such as fishing and tourism. This month we have published a <u>short</u> <u>research paper on river sand mining by Bethia</u> <u>Kadoe</u>, a Myanmar student intern with MCRB and WWF in 2017, and commented publicly on a <u>plan</u> to extract 5 million tons of sand in the Myeik <u>archipelago</u>, and the impacts this could have on fisheries inter alia.
