Combatting corruption – forthcoming seminar

Launching the research phase for Pwint Thit Sa 2019

The 2019 Pwint Thit Sa (Transparency in Myanmar Enterprises) assessment will be undertaken by MCRB, again in partnership with Yever. A briefing was held for companies on 10 September. It will assess information disclosure on the corporate websites of around 250 large Myanmar companies including for the first time, state-owned enterprises. First draft assessments will be sent to companies in November.



Myanmar Needs a People-Centred Cybersecurity Framework

MCRB contributed to a seminar organised by Telenor on 'Privacy and Data Protection in the Digital Age' in Nay Pyi Taw. It was attended by around 40 participants from the Post and Telecommunications Department (PTD), the Information Technology and Cyber Security Department (ITCS), the Cybercrime unit of Myanmar Police Force, Union Attorney General's Office (UAGO), as well as some telecoms companies.
