# Save the date: 5th National Conference on Communities and Tourism (NCCT) 2020

The fifth National Conference on Communities and Tourism (NCCT) will take place this year on 21-23 May, in Dawei, bringing together participants representing tourism businesses and associations, community-based tourism (CBT) groups, CSOs from across Myanmar with a particular focus on those working in tourism in Tanintharyi Region. The training covered responsible business, Environmental Impact Assessments (EIA), resettlement and grievance mechanisms, with a focus on oil and gas.
