### How should land laws be reformed?

The Union Attorney-General is overseeing development of a new National Land Law. MCRB has provided comments on their draft Action Plan and encouraged government to take account of the challenges business face in trying to operate responsibly under the existing legal framework. MCRB will be collaborating with the United Nations Development Programme and others to gather evidence on this from companies and their professional advisers.



## MCRB welcomes (back) our new Deputy Director!

Thi Thi Thein, who worked at the Centre five years ago has re-joined the MCRB as Deputy Director, focussing on Policy and Advocacy. Ma Thi Thi will oversee MCRB's work on policy and legal framework analysis and advocacy. She will also manage MCRB's sectoral work on extractives and digital rights, and on crosscutting issues including labour, land, the impacts of business on vulnerable groups, environmental impact assessment and public participation.



### Pwint Thit Sa 2020: Final countdown!

The Transparency team is currently finalising the Pwint Thit Sa/Transparency in Myanmar Enterprises 2020 Report. Over 270 Myanmar companies have been assessed, and some have improved their corporate disclosure. The report will issue in December 2020.
