These half-day workshops are organised by Myanmar Centre for Responsible Business as Secretariat to the in-country Steering Group of the Voluntary Principle on Security and Human Rights (VPSHR). The workshops will explain the VPSHR to relevant stakeholders in Myanmar, including government officials, security companies, extractives companies, and other stakeholders, and discuss how they could be implemented in Myanmar.

THE VOLUNTARY PRINCIPLES ON SECURITY AND HUMAN RIGHTS were established in 2000 as a multistakeholder initiative (MSI) involving governments, companies, and non-governmental organizations that promotes implementation of a set of principles that companies in the extractives industries on providing security for their operations in a manner that respects human rights. Specifically, the Voluntary Principles guide companies in conducting a comprehensive human rights risk assessment in their engagement with public and private security providers to ensure human rights are respected in the protection of company facilities and premises.
