2. The duties and responsibilities of the Employment Sub-committee are to:

(a) Undertake responsibilities in line with the guidance of the Working Committee on the Rights of Persons with Disabilities.

(b) Study, analyze and make recommendations and undertake relevant coordination to enable the adoption of the policies and plans that support employment of persons with disabilities in accordance with the Law on Protecting the Employment Rights of Persons with Disabilities.

(c) Study, analyze and make recommendations and submit reports to the Working Committee and undertake relevant coordination to ensure technical and vocational education and training includes more persons with disabilities.

(d) undertake relevant coordination concerning the provision duty and tax exemptions/ reductions to support employment of persons with disabilities.

(e) Raise awareness with government departments and employers concerning the promotion of employment opportunities for persons with disabilities in accordance with the policies and plans of the National Committee.

(f) Collect data of persons with disabilities, who have already registered their personal information with employment departments and offices, using appropriate methods including digital technology and computer software, and arrange to connect with organization working with employers and overseas employment agencies for employment opportunities.

(g) Ensure that currently operating government and non-government organizations, training schools include a proportionate number of persons with disabilities, analyze and submit reports on behalf of Working Committee on the implementation of capacity-building programs for persons with disability, provide advice on needs and undertake coordination and collaboration more effectively

(h) Plan, supervise and coordinate provision of training programs for recruitment of persons with disabilities in respective workplaces and workplace safety and relations, raise awareness of workplace and labour laws, and training of workplace supervisors

(i) Undertake joint activities with the National Committee and coordinate with relevant bodies to draw up a 10 year Master Plan for employment opportunities for persons with disabilities.
